What data do we collect?

Muzz.app collects the following data:

• Personal identification information (Name, email address, etc.)

How do we collect your data?

You directly provide Muzz.app with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Use the Account and Data management personal sections of the website.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Muzz.app collects your data so that we can:

- Process your order and manage your account.
- Email you with newsletters and special offers on products and services we think you might like.

When Muzz.app processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Muzz.app securely stores your data at with the Cloud infrastructure provider Scaleway (Cf. https://www.scaleway.com/en/), and the platform itself operates under a strong SSL certificate with authentication required databases.

Muzz.app might keep your personal data and all related collections metadata and content for 1 year after you deleted your account for administrative/logistical purpose. Once this time period has expired, we will completely delete your data and all related collections metadata and content.

What are your data protection rights?

Muzz.app would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Muzz.app for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Muzz.app correct any information you believe is inaccurate. You also have the right to request Muzz.app to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Muzz.app erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Muzz.app restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Muzz.app's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Muzz.app transfer the data that we have collected to another organization, or directly to you, under certain conditions.
